STUDENT'S DECLARATION

III. Aims and basis for processing:

The personal details shall be processed for the purpose of applying for the Rector's Award for outstanding students who pursue their studies in a foreign language at the University of Warmia and Mazury in Olsztyn, for settlement and archiving purposes, and if the Award is granted, for the purpose of publishing information about the awards.

Your personal details shall be processed pursuant to your consent (Art. 6 (1) (a) of GDPR) and as it is necessary to fulfil the controller's legal obligation (Art. 6 (1) (c) of GDPR).

IV. Categories of data to be processed:

Name(s) and surname, date and place of birth, e-mail address, telephone number, and if the award is granted – the image and the bank account number.

V. Data recipient:

The personal data shall not be shared with other entities except in situations described in this information or provided for by the law.

VI. Duration of data storage:

The personal details shall be kept until you complete your studies, and if the award is granted – they shall be further processed under the archival regulations.

VII. Your rights:

You are entitled to:

- a) access your data and receive a copy,
- b) correct your data,
- c) have your data deleted,
- d) restrict your data processing,
- e) object to your personal data being processed,
- f) have your data transferred,
- g) file a complaint with a regulatory body,
- h) withdraw your consent to your data being processed.
