SEMINAR: 1. Primary and secondary skin lesions in dermatoses. 2. Bacterial, viral and parasite skin infections. 3. Fungal infections. 4. Allergic skin diseases. 5. Erythemas. Lichen planus. 6. Urticaria and drug induced skin reactions. 7. Leg ulcers. 8. Autoimmunological skin diseases. 9. Bullous diseases. 10. Sexual transmitted diseases.

TEACHING FORMS AND METHODS:

Lecture(W1;K5;):A student who meets all the criteria for admission to the exam takes an oral exam at the Coordinator of the subject or the Head of the Department and Clinic of Dermatology, Sexually Transmitted Diseases and Clinical Immunology.

Seminar(W1;K3;K5;):Assessment of work and cooperation in a group. Classes(W1;U1;K1;K2;K3;K4;K5;):During exercises in the subject, the student: 1. Describes patients' skin changes. 2. Draws up the history of the patient's illness assigned by the assistant. 3. Learns the methods of diagnosing skin diseases.
