SUBJECT MATTER CONTENT

LECTURE

1. The biopsychosocial model of health and disease. 2. Psychological definitions of health and risk behavior: beliefs, motivation, personality, social norms. 3. Psychological theories AND mechanisms of stress. Coping styles. 4. Practical techniques to reduce stress: cognitive-rational, emotional, behavioral, relaxation techniques, breathing, yoga, self-massage, mental hygiene, importance of social support. 5. Burnout in the medical profession: mechanisms of formation AND prevention.

SEMINAR

Models of modification of health-seeking behavior. Psychological interventions to reduce risk behaviors. Assumptions of motivational interviewing. Psychosocial determinants and consequences of selected somatic diseases: oncological, cardiovascular, respiratory, gastrointestinal diseases.

CLASSES

Practical exercises in recognizing emotions AND coping with them (reactions to anger, anxiety depression). Communication exercises, recognizing communication barriers, opportunities for improvement, conveying bad news, information about an unfavorable prognosis. ABCs of providing psychological assistance. Practical relaxation exercises.

TEACHING OBJECTIVE

Getting acquinted with basic psychological concepts relevant to health related behaviours and risk behaviours (including beliefs, motivation, emotions, personality, social influence, classical and instrumental conditioning, social support). Introducing basic information about psychological and social factors contributing to health maintenance and risk factors for developing diseases (including smoking, alcohol consumption and obesity). Highlighting the importance of adaptation process to chronic and terminal conditions with its psychological and social conditions. Analysis of stress mechanisms, psychosocial stressors, different techniques of coping with stress. Familiarizing with basic techniques of psychological help in medical contexts. Practising skills of making contact with patients and their families (especially in difficult situations including delivery of bad news). Practising team work skills.
