TEACHING OBJECTIVE:

This course is designed to introduce you to some of the central issues of medical ethics. Medical ethics addresses these questions in the context of patient care and the distribution of medical attention, and seeks to determine which actions or options in medical practice are obligatory, which permissible, and which impermissible.

By the end of the course you should be familiar with the major ethical theories relevant to medical practice, and be able to apply these theories to ethical issues.

In terms of skills, (indicated by letter U- Polish language term "U"-/ "skills"), the graduate is able to: adhere to ethical standards in professional actions, including planning and conducting therapeutic processes in accordance with ethical values and the idea of humanism in medicine; recognize the ethical dimension of medical decisions and distinguish factual aspects from normative ones; adhere to patient rights; demonstrate responsibility for enhancing their qualifications and transferring knowledge to others; recognize one's own emotions and manage them in relationships with others to effectively carry out work despite personal emotional reactions; describe and critically evaluate one's own behavior and communication style, considering the possibility of alternative actions; look at the situation from the patient's perspective, build an appropriate context for the conversation, use elicitation methods, and incorporate it into verbal communication.

establishing and maintaining deep and respectful contact with the patient, as well as demonstrating understanding of

worldview and cultural differences; Acting in the best interest of the patient; maintaining medical confidentiality and respecting patients' rights; taking actions towards the patient based on ethical principles, with an awareness of the social conditions and limitations resulting from the illness; 6. applying the principles of professional collegiality and teamwork, including collaboration with representatives of other medical professions, also in multicultural and multinational environments.
