#### **LEARNING OUTCOMES:**

#### Knowledge

W1 - The student knows and understands: - legal regulations regarding medical confidentiality, keeping medical records, criminal, civil and professional liability of a doctor; - basics of disinfection, sterilization and aseptic procedures; - basic principles of pharmacotherapy; - individual groups of therapeutic agents; basic principles of pharmacotherapy; major drug side effects, including drug interactions; groups of drugs, the abuse of which can lead to poisoning; - the importance of verbal and non-verbal communication in the process of communicating with the patient and the concept of trust in interaction with the patient; - principles of nutrition for healthy and sick children, including natural feeding, preventive vaccinations and keeping a health balance of the child; the consequences of improper nutrition, including prolonged starvation, excessive eating and the use of an unbalanced diet, and disorders of digestion and absorption of digestive products; - principles of perioperative safety, patient preparation for surgery, general and local anesthesia and controlled sedation; - postoperative treatment with analgesic therapy and postoperative monitoring; - principles of diagnosis and therapeutic management in the most common problems of palliative medicine, including: 1) symptomatic treatment of the most common somatic symptoms, 2) treatment of neoplastic cachexia and the prevention and treatment of pressure ulcers, 3) the most common emergencies in palliative medicine; - principles of motivating the patient to pro-health behaviors and informing about unfavorable prognosis;

#### Skills

U1 - The student is able to indicate the rights of the patient, can provide care with respect for the patient's dignity. The student can: - keep the patient's medical records. - follow the rules of asepsis and antisepsis; - prepare a written and oral report on the patient's condition and applied medical and emergency measures, report to the supervisor and the interdisciplinary team; - conduct a medical interview with an adult patient; - perform basic procedures and medical treatments, including: 1) body temperature measurement (superficial and deep), pulse measurement, non-invasive blood pressure measurement, 2) monitoring of vital signs with a cardiomonitor, pulse oximetry, - plan diagnostic, therapeutic and prophylactic procedures - perform simple pharmacokinetic calculations; select drugs in appropriate doses in order to correct pathological phenomena in the body and in individual organs; - put on a peripheral puncture; dress a straight wound, put on and change a sterile surgical dressing; assess pressure ulcers and apply appropriate dressings; - act in case of injuries (apply a dressing or immobilize, dress and suture the wound); perform temporary immobilization of the limb, select the type of immobilization necessary for use in typical clinical situations and control the correctness of blood supply to the limb after applying the immobilizing dressing; supply external bleeding; - apply nutritional treatment, including enteral and parenteral nutrition; - monitor the patient's condition in the postoperative period based on vital parameters; - demonstrate responsibility for improving their qualifications and transferring knowledge to others;
